

ARTICLES OF INCORPORATION

The HOPE CENTER for kids INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARPICLE ONE: NAME: The name of the corporation shall be The HOPE CENTER for kids INC.

ARFICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ATTICLE THREE: PURPOSE: The purpose of the corporation is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act. To Provide care for medically fragile children, physically and or mentally impaired and to provide a play/craft center for the children. The HOPE CENTER for kids like., also may own, buy, and sell parts or all of other businesses, real estate, and investments; conduct research; develop equipment; design, construct, own, sell, and lease equipment; and hold patents. The HOPE CENTER for kids INC., may do writing of all types, including printing, publishing, distributing, buying, and selling; enter into textiles and their manufacture, distribution, sales, e(c.; and take advantage of any and all opportunities, ventures, and spin-offs that are legally available.

ARFICLE FOUR: CAPITAL STOCK: The aggregate number of shares which the corporation has authority to issue is one hundred (100) shares, all of which shall be common shares with a par value of no par value.
