

**ARTICLE I - NAME**

The name of this corporation is CAREER SALES OPPORTUNITY MAGAZINE CORP.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on date of filing.

**ARTICLE III - PURPOSE**

The Corporation shall indemnify any officer or Director, or any former Officer or Director, to the full extent permitted by law.


