

## ARTICLES OF INCORPORATION OF PRUDENCE DEVELOPMENT, INC.

The undersigned incorporators to these articles of Incorporation, a Florida corporation, hereby form a corporation under the laws of the state of Florida.

ARTICLE I. CORPORATE NAME.

The name of this Corporation is:

PRUDENCE DEVELOPMENT, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the state of Florida.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of capital stock which this Corporation is authorized to issue and have outstanding at any time is:

- (1) Common Stock Class "A" 100 Shares, having a par value of one (\$.01) cent per share;
- (2) Common Stock Class "B" 9,900 Shares, having a par value of one (\$.01) cent per share;

The capital stock that this Corporation is authorized to issue and have outstanding shall have the following rights, preferences, designations and limitations:

(1) Voting Rights.

(A) Common Stock - Class "A". Each holder of shares of Common stock -

Class "A" of this Corporation shall be entitled to one (1) vote for each such share standing in his name at the time of any meeting of stockholders of this Corporation.

(b) <u>Common Stock-Class "B"</u>. Holders of shares of Common Stock - Class "B" of this Corporation shall not be entitled to vote at any meeting of Stockholders of this Corporation.

(2) Other Rights. In all respects other than voting rights as stated above, all rights, privileges, preferences, and immunities of Common Stock - Class "A" and Common Stock - Class "B" shall be identical.

ATRICLE IV. <u>TERM OF EXISTENCE</u>.

This corporation shall have perpetual existence.

ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.
