We the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

ARTICLE I

Name

The name of the Corporation shall be **CONSOLIDATED INTERIORS, INC.**, and the street address of its principal place of business shall be located at 321 East 6th St., Chuluota, FL 32766, and the mailing address of the corporation is 321 East 6th St., Chuluota, FL 32766.

ARTICLE II

Term

This Corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

Purpose
