The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation to be effective upon filing.

ARTICLE I. NAME

The name of the company shall be: KIMS ALTERATIONS, INC.

Any vacancy on the board of directors may be filled by action of the board until the next shareholder meeting. Such notification shall contain the following: (A) name and address of the proposed nominee (s), (B) principal occupation of the proposed nominee, (C) total number of shares to be voted for the proposed nominee, (D) the name and address of the shareholder submitting the nomination, (E) total number of shares owned by the shareholder submitting the nomination.
