The undersigned Incorporator, a natural person of legal age, hereby subscribes to, acknowledges and adopts the following Articles of Incorporation for the purpose of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, Chapter 621, Florida Statutes.

ARTICLE I

Name

The name of this Corporation ("Corporation") is:

ARTICLE II

Principal Office
