# ARTICLES OF INCORPORATION

OF

## POTURA CONTINGS OF JACKSONVILLE, INC.

The undersigned, acting as incorporator of a corporation under Florida General Corporation Act, adopts the following Articles@of Incorporation for such corporation:

### ARTICLE I - NAME

The name of the corporation is Potura Coatings of Jacksonville,

#### ARTICLE II - TERM OF EXISTANCE
