ARTICLES OF INCORPORATION

OF

The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be HOT WATER FAST, INC.

ARTICLE II

The principal office and mailing address of the Corporation is 2871 Hypoluxo Road, Lantana, FL 33462.

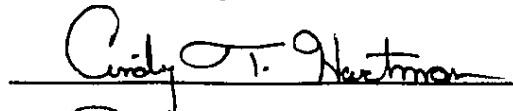

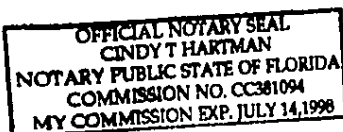
