# ARTICLE I - NAME

The name of this corporation is DURA BUILT BARS AND CONSTRUCTION, INC.

# ARTICLE II - LOCATION

The principal office of this corporation is to be located at 236 W. Prospect Road, County of Broward, Fort Lauderdale, Florida 33309.

# ARTICLE III - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
