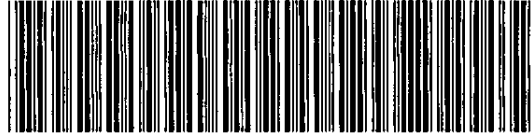

The dissolution was authorized on August 26, 2015. The dissolution will be effective September 1, 2015.

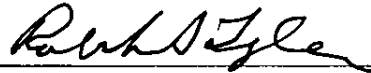
