**ARTICLES OF INCORPORATION
OF

I the undersigned incorporator of a Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is MEDICAL MOTIVATIONS, INC.
