ARTICLES OF INCORPORATION

of

HARPER ABSOCIATIONS MANAGEMENT, INCORPORATED

ARTICLE I

NAME

The name of the Corporation is HARPER ASSOCIATIONS MANAGEMENT, INCORPORATED, (hereinafter referred to in this document as "the Corporation").

ARTICLE II

DURATION

The Corporation shall have perpetual existence, unless it shall hereafter be dissolved according to law.

this Corporation who is also a Director or Officer of such other

Corporation, or who is so interested, may be counted in the

determining the existence of a quorum at any meeting of the Board

of Directors of this Corporation, which shall authorize any such

contract or transaction with like force and effect as if he were

not such Director or Officer of such other Corporation or not

interested.

DRTICLE X PREEMPTIVE RIGHTS

Every shareholder, upon the sale of any additional stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
