I have received the second notice re the 1999 Profit Corporation Annual Report packet for Harper Associations Management, Inc. formally of Gulfport, Florida. Since the corporation was totally inactive in 1998 even though it was registered, and I moved from Florida to North Carolina on or about December 1, 1998 where I am totally retired I chose not to renew the corporation for 1999. Your records will indicate that I was the sole officer and stockholder. Prior to relocating I placed my Florida Condominium Manager's license on an inactive status. I do not foresee me returning to Florida to resume active employment in the condominium field, nor do I intend to use the Harper Associations Management, Inc. name as an active company in North Carolina since I have an acute hearing deficiency, and find it impossible to pursue any activity which requires me to use even an amplified telephone to any extent much less understand conversations which would be necessary in attending meetings.

For your records I have enclosed the address page of the packet which indicates that it was forwarded to me in North Carolina by the U.S. Postal service. Since I am "out of business" so to speak please delete the corporation from your active files.

IMPORTANT NOTICE REGARDING THE STATUS OF YOUR CORPORATION

You have indicated that your corporation has been sold or is no longer actively transacting business. The corporation shown on the enclosed annual report will be administratively dissolved/revoked by the Division of Corporations at a later date this year if the Corporation Annual Report is not filed, or the corporation can choose to voluntarily dissolve or withdraw by filing Articles of Dissolution for a domestic corporation or a Certificate of Withdrawal for a foreign corporation. Enclosed is the appropriate form. The fee to voluntarily dissolve or withdraw is \$35. There is no fee if the Department of State administratively dissolves/revokes the corporation.

IF THE CORPORATION CHOOSES NOT TO FILE THE ANNUAL REPORT AND DOES NOT VOLUNTARILY DISSOLVE OR WITHDRAW, IT WILL AUTOMATICALLY RECEIVE A 60 DAY NOTICE OF INTENT TO ADMINISTRATIVELY DISSOLVE/REVOKE IN JUNE AND A CERTIFICATE OF DISSOLUTION/REVOCATION IN SEPTEMBER. FLORIDA LAW REQUIRES THAT WE SEND THESE NOTICES TO EACH CORPORATION BEFORE AND AT THE TIME OF ADMINISTRATIVE DISSOLUTION/REVOCATION.

NOTE: THERE IS NO PROVISION TO PLACE A CORPORATION ON "INACTIVE STATUS" WITH THE DIVISION OF CORPORATIONS.



Thank you for your letter of July 13, 1999, a copy of which is attached for your convenience. I have enclosed form ARTICLES OF DISSOLUTION which I have completed along with a check in the amount of \$35.00. Please note that this check is drawn on my personal account since the corporation which is to be dissolved did not produce any income for the years 1998 and 1999, and has no checking account nor assets. Your letter states that there is no fee if the Department of State administratively dissolves/revokes the corporation.
