# ARTICLES OF INCORPORTION OF ERIC SWATEK, INC.



The undersigned, for the purpose of forming a corportion under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is Eric Swatck, Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of May 1, 1998.

# ARTICLE THREE PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

#### ARTICLE FOUR CAPITAL STOCK
