# ARTICLES OF INCORPORATION OF ROYAL TRAPERS CORPORATION

THE UNDERSTGNED, have executed the following document as incorporator of the above named Corporation, organized under the laws of the State of Florida, and all rights, duties and obligations of the undersign as incorporator, and those of the Corporation, are to be cormined in accordance with the laws of the State of Florida.

# ARTICLE I
