The undersigned, acting as incorporators of the captioned corporation, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I
Corporate Name**

The name of the corporation is:

**ARTICLE II
Commencement of Corporate Existence**

The corporation shall come into existence on the date the State of Florida, Division of Corporations, receives and files these Articles, and shall have perpetual existence.

**ARTICLE III
General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV
Capital Stock


