ARTICLES OF INCORPORATION OF SOUTHEASTERN EXTERIORS, INC.

- 1. Namo. The name of the corporation is: SOUTHEASTERN EXTERIORS, INC.
- 2. Purpose. The corporation may engage in any logal business.
- 3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share.
