ARTICLES OF INCORPORATION OF LAWRENCE K. TESHER, INC.



The Undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

- The name of the corporation is as follows:
