# ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation make, subscribe and acknowledge the following Articles of Incorporation under the laws of the State of Florida.

#### ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be: INTERNATIONAL INSTITUTE OF INFORMATICS AND SYSTEMICS, CORP.

#### ARTICLE II - TERM OF EXISTENCE
