ARTICLE I - NAME

The name of this Corporation is Kylor, Inc. The mailing address is: 1461 Banks Road, Margate, Florida 33063.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on April 18, 1996.

ARTICLE III - PURPOSE


