### ARTICLES OF INCORPORATION

### COMPREHENSIVE COMMUNITY RESOURCES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### **ARTICLE 1**

The name of the corporation is: COMPREHENSIVE COMMUNITY RESOURCES, INC.

### ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

### **ARTICLE III**

The corporation is authorized to have outstanding one class of stock designated as common stock. The maximum number of shares of common stock which the corporation is authorized to have outstanding is 1,000 shares at a par value of \$1.00 per share. Holders of the common stock are entitled to vote on all questions required by law on the basis of one vote per share and there shall be no cumulative voting.
