The undersigned, in order to form a corporation under and pursuant to the provisions of the  
Law of Florida for the purposes set forth below, hereby subscribe to these Articles of Incorporation.

## **ARTICLE I.**

## ARTICLE II.

The purpose and general nature of the business to be conducted and transacted by the corporation shall be as follows:

C. To draw, make, accept, endorse, discount, execute, and issue promissory notes, bills of exchange, and other negotiable instruments, including bonds, debentures, or other obligations of this corporation, whether secured by mortgagee pledge, or otherwise, or unsecured, for money borrowed, or in payment for property purchased or acquired, or for other lawful objects.

D. To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of capital stock, or any bonds, securities, or other evidences of indebtedness, created by any corporation and while owner of such stock or evidence of indebtedness, to exercise all of the rights, powers, and privileges of ownership, including the right to vote according to the rights of said instruments and agreements.
