ARTICLES OF INCORPORATION OF A.L.S. MORTGAGE COMPANY

DIVISION 26 PHI2: 57

ARTICLE I

The name of the Corporation is A.L.S. MORTGAGE COMPANY.

ARTICLE II

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
