ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, for the purposes of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is "'ROUND THE CORNER, INC."

ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The number of shares of stock which this Corporation is authorized to issue and have outstanding at any one time is 2,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV - DURATION; EFFECTIVE DATE

This Corporation shall exist perpetually, commencing on April 25, 1996.

ARTICLE V - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial street address of the principal office and the mailing address of this Corporation is 2233 Ironstone Drive West, Jacksonville, Florida 32246. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VI - DIRECTORS

The Corporation shall have one (1) Director initially. The number of Directors may be increased or decreased from time to time as set forth in the Bylaws, but shall never

The Board of Directors is hereby specifically authorized to make provisions for the indemnification of Directors, officers, employees and agents of this Corporation, to the fullest extent permitted by law.

ARTICLE XI - AMENDMENT

These Article of Incorporation may be amended, altered, or repealed at any time, and from time to time, in the manner now or hereafter prescribed by the applicable Florida Statutes, as amended from time to time, and all rights conferred on a shareholder herein are granted subject to this reservation.
