Dear Ms. Mortham

The purpose of this letter is to explain to you why I did not pay my corporation fees for 1997 and 1998 and to request a waiver of the penalty.

In 1996 I relocated from Atlanta, Georgia to purchase a Wendy's Restaurant franchise in North Miami Beach, Florida. I employed the services of an accountant and an attorney in Clearwater, FL. Additionally I rented an apartment that I moved out of four months later. I officially notified the post office of my new mailing address. For a period of time the new occupant of the apartment called to inform me of mail he was

saving. I never received any fee statements from your office. If I had I certainly would have paid them.

Ms. Mortham I am not familiar with Florida law and certainly was not aware that I owed the state money until I requested a bond form from Florida Power & Light.

In a conversation with one of your employees at the reinstatement office she basically said "I ignorance is no excuse". But, Ms. Mortham, if you don't know - you don't know!

My business has not done well so any additional penalties or fees will be a great burden.

Again I ask that you take all of the above into consideration and accept the enclosed check for 315.⁰⁰ as full payment.
