The undersigned, acting as incorporator of Sprug Studios, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Amalfi Drive Group, Inc., and the mailing address of this Corporation is 2569 Tigertail Avenue, coconut Grove, FL 33133.

ARTICLE II - COMMENCEMENT OF EXISTENCE


