ARTICLES OF INCORPORATION 96 APR 26 PM 3:38

ARTICLE I - NAME TALLAHASSEE, FLORIDA

The name of this corporation is Genique Medical Products, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
