I, the undersigned incorporator of this corporation, under Florida Statutes 607 amended, adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation is: RESEARCH DATA, INC. The principal place of business of this corporation shall be at 18090 Collins Avenue, Suite 190, Miami Beach, Florida 33160.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any lawful activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock which this corporation is authorized to have at any one time is One Hundred (100) shares of common stock of Five (\$5.00) Dollars par value.
