ARTICLE I - NAME

The name of this corporation is ADVANCED HOME TECHNOLOGIES CORPORATION (the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the initial principal place of business of the Corporation is 2618 Miller Road, Valrico, Florida 33594. The initial mailing address of the Corporation is 2618 Miller Road, Valrico, Florida 33594.

ARTICLE III - COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence at 8:00 a.m. on the date of filing of these Articles of Incorporation.

ARTICLE IV - PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE V - AUTHORIZED SHARES

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$0.10 per share.

ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

#### ARTICLE VII - INCORPORATOR

The Corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.
