

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is ADVANCED HOME TECHNOLOGIES CORPORATION (the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence at 8:00 a.m. on the date of filing of these Articles of Incorporation.

ARTICLE IV - PURPOSE

ARTICLE V - AUTHORIZED SHARES

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$0.10 per share.
