# **ARTICLES OF INCORPORATION**

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I. NAME

The name of this corporation shall be CARRILLO MAINTENANCE, INC.

# ARTICLE II. PLACE OF BUSINESS

The principle place of business and mailing address of **CARRILLO MAINTENANCE**, **INC.** is 360 Roosevelt Street, Oviedo, Florida 32765.

# **ARTICLE III. DURATION**

This corporation shall have perpetual existence.

# **ARTICLE IV. PURPOSE**
