ARTICLES OF INCORPORATION  
OF

The undersigned incorporators, natural persons, competent to contract, hereby form a Corporation under the Laws of the State of Florida.

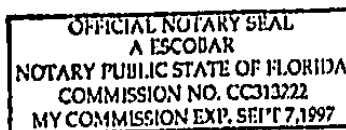
