

ARTICLES OF INCORPORATION
OF
AMERICAN GATEWAY TRADING CORPORATION

ARTICLE I

The name of this Corporation is: American Gateway Trading Corporation

liability that might otherwise exist from thus contracting with this Corporation for the benefit of himself or any firm, association or corporation in which he may be anywise interested. Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anywise interested.
