ARTICLES OF INCORPORATION OF TRANSWORLD RESPIRATORY, INC.

THE PROPERTY OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name EFFECTIVE DATE

Section 1.1. Name. The name of this corporation shall be TransWorld Respiratory, Inc.

Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 8400 Baymeadows Way, Suite 3, Jacksonville, Florida 32256.

Article III Capital Stock
