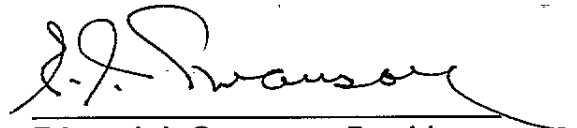
1. Article I of the Articles of Incorporation of HUMAN RESOURCE ALTERNATIVES, INC. is hereby amended in its entirety to read as follows:
