#### ARTICLES OF INCORPORATION

OF

#### JODI P. DORN, INC.

THE UNDERSIGNED, acting as solo incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE 1**

The name of the corporation shall be: JODI P. DORN, INC.

The address and mailing addess of the corporation's principal office shall be:

#### **ARTICLE II**

The period of its duration is perpetual.

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder of common stock currently authorized and issued.
