

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.


**ARTICLE V**

The name and address of the initial incorporator is Arnolds Sachs, 4800 SW 64th Ave., Suite 102 B, Davie, Fl. 33314.




