ARTICLE

The name of this Corporation is Career Development Technologies, Inc. .

<u>ARTICLE II</u>

The Corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes. While pursuing its purposes, the Corporation may exercise the powers granted now or in the future by Chapter 607, Florida Statutes, and by common law.

ARTICLE III

The aggregate number of shares which the Corporation shall have the authority to issue shall be 100,000 shares of common stock, which shall be comprised of 85,000 shares of voting stock and 15,000 shares of non-voting stock.
