ARTICLES OF INCORPORATION
OF
NP'S ACUPUNCTURE & HERBAL SCIENCES CENTER, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be NP'S ACUPUNCTURE & HERBAL SCIENCES CENTER, INC.
