ARTICLES OF INCORPORATION

TO: SECRETARY OF STATE, STATE OF FLORIDA, TALLAMASSES, FLORIDA

Wo, the undersigned natural persons of the age of twenty-one or more, acting as incorporator of a corporation under title 607.164, of the LAWS of the State of Florida, adopt the following Articles of Incorporation for such corporation.

- 1. The name of the corporation, hereinafter referred to as the Corporation, shall be Cherene Enterprises Inc.
- 2. The duration of the Corporation shall be perpetual.
- 3. The object and purpose for which the Corporation is formed is to engage in the ownership and management of a vending machines business and any other business permitted by law.
- 4. The aggregate number of shares which the corporation is initially authorized to issue is one thousand (1000). There shall be one class of stock with a par value of one dollar (\$1.00). There shall be no preferences, qualifications, limitations, restrictions or special rights with respect to the one class of stock.
- 5. Shareholders have the pre-emptive right to acquire additional shares of stock.
- 6. Provisions for the regulation of the internal affairs of the corporation are contained in By-Laws of the Corporation.

- 7. The Corporation will not commence business until at least one thousand dollars (\$ 1,000) has been received by it as consideration for the issuance of shares.
- 8. The initial register office and principal place of the Corporation shall be located at: 11471 NW 39th Street, Sunrise FL, 33323. The initial registered agent is Ronald Cherene.
- 9. The following persons shall constitute the initial Board of Directors of the Corporation, and shall serve until the first annual meeting, or until, their successors shall be elected:

- 10. The incorporators of this corporation are Ronald Cherene and Victoria Cherene whom resides at the address stated in Paragraph 9.
- 11. The Articles of Incorporation shall constitute a binding agreement and may be amended by the affirmative vote of majority of the Board of Directors in Office.
- 12. The registered agent acknowledges the he/she is familiar with and accepts, the duties and responsibilities of registered agent for this Corporation.
