ARTICLES OF INCORPORATION

I, RANDY TUNDIDOR, being of legal age, do hereby sign these presents for the purposes of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE 1

The name of the corporation shall be:

The general nature of the business and the objects and purpose to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

- B.
