ARTICLES OF INCORPORATION
OF
CONCEPTS - NEW BEGINNINGS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The Corporate name is: CONCEPTS - NEW BEGINNINGS, INC.

ARTICLE TWO

The principle place of business and mailing address of this corporation shall be:

ARTICLE THREE

DURATION

The duration of the Corporation is perpetual.

ARTICLE FOUR

PURPOSE

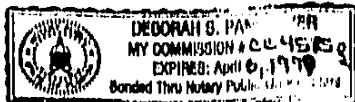
