ARTICLES OF INCORPORATION OF P & ANNIE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation (National Market Business adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION
