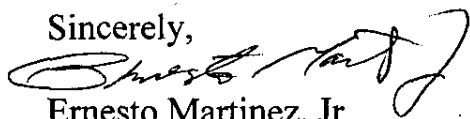
I spoke to someone in your office who indicated that I should send a letter explaining that I changed address and that I did not receive the annual report.
