ARTICLE V: INCORPORATOR

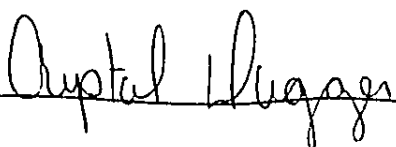
