— To whom it may concern: —

On July 07, 2004 I was informed by a friend that the State of Florida requires all businesses to submit an annual report and fee to your office.

This information shocked me, as the company's office manager, I had not been advised of this requirement, and have not fulfilled this procedure. We went on line and discovered that our company, "Europe Florida Paradise Realty, Inc.", registered by the State on April 30, 1996----# P96000037340 had in fact been dissolved by the State.

I believe that the problem of not receiving notification from the State about this annual requirement was due to our office relocating to a new address on July 01, 1999 and perhaps such notices were not forwarded to our new location.

I deeply regret my ignorance on this matter, and kindly request reinstatement of our corporate name. I was advised by a representative in your office today to submit a letter explaining the background, a reinstatement application and a check covering the 5 years (2000---2001---2002---2003 and 2004) period when the reports and payments were not made by us. Accordingly, the enclosed check for \$ 750.00 covers the annual fee of \$150.00 for this 5 year period. Your representative also advised that the penalty fee could be waived for circumstances such as I have described. I have enclosed a copy of the termination of lease letter to verify our relocation on July 01, 1999.

I appreciate your consideration of my waiver request, and anxiously await your response and corporation name reinstatement.
