The undersigned incorporators, all of whom are duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, hereby adopt and file the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation is Cutler & West, P.A.




