#### ARTICLE I

#### Name

The name of this Corporation is Riverside Trophies and Printing, Inc.

#### ARTICLE II

# Duration

This Corporation shall have perpetual existence.

# ARTICLE III

#### Purpose

The object and purpose of the corporation and the general nature of the business or businesses to be transacted by it shall be as follows:


