The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME: The name of the Corporation is F & A SALES, INC.

ARTICLE II. <u>DURATIONS</u>: The term of existence of the Corporation is perpetual.
