ARTICLES OF INCORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME: The name of the Corporation is F & A SALES, INC.

ARTICLE II. DURATIONS: The term of existence of the Corporation is perpetual.

ARTICLE III. PURPOSE: The Corporation may transact and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV. CAPITAL STOCK: The aggregate number of shares which the corporation has authority to issue is One Hundred (100) shares, all of which shall be common shares with a par value of Five Dollars (\$5.00) each.

ARTICLE V. REGISTERED OFFICE: The street office of the initial principal and registered office of the Corporation is Palm Warehouse, Bay #11, 1900 N.W. 33rd Court, Pompano Beach, Florida 33064, and the name of the initial registered agent at such address is Aaron Strom.

ARTICLE VI. DIRECTOR: The Corporation shall have one (1) director, initially. The number of directors may be increased, from time to time, by By-Laws adopted by the stockholders, but shall never be less than one (1).

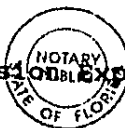
